





• Registration of Cyprus Company at the Business Facilitation Unit – Registration of Companies with Foreign Interests

### Registration of Cyprus Companies with Foreign Interests

• To be classified as a company with foreign interests, the company must register with the Business Facilitation Unit (BFU) of the Ministry of Energy, Commerce, and Industry. Registration is eligible when the majority of the company's shares are owned by nationals of third countries.

The following key requirements should be noted:

- The ultimate beneficial owner/s (UBOs) must deposit €200,000 into a company account held with a credit institution licensed by the Central Bank (excluding payment institutions).
- The company must also provide evidence of the physical office of the business. It is important to note that the address provided must be the physical location where the business operates, not just the registered office address of the company.
- Upon successful application, the company will receive written confirmation of its registration in the new Register of Foreign Interest Companies.
- This registration will then be submitted to the Migration Department to facilitate the issuance of residence and employment permits.
