

Corporate Bank Account Opening

In order to initiate a corporate bank account opening the following documents are required by the bank:

- Full set of Corporate Documents (Certification by notary and apostille may be required by the bank)
- Ownership / group structure leading to the beneficial owner
- Audited Financial Statements or Management Accounts for offshore jurisdictions
- KYC documents of the authorized signatories, registered shareholders, and ultimate beneficial owners
- Information for Source of Funds and Value of Wealth for the ultimate beneficial owners (as per bank's request)
- Trust Deed/Declaration of Trust/Other similar trust agreement between the ultimate beneficial owner and the registered shareholder
- Financial Details (i.e. Annual income, Number of employees, Anticipated credit amounts and credit turnover on bank account, as well as the expected incoming and outgoing counterparties must be provided)
- Description of company's line of business

^{*} The above is an indicative list of items needed. Each bank has its own requirements and extra documentation may be requested.



Personal Bank Account Opening

In order to initiate a personal bank account opening the following documents are required by the bank:

- Copy of the Passport
- CV
- Copy of Proof of address
- Copy of the Employment Agreement (if applicable)
- Copy of Clean Criminal Record
- Email and Local Mobile number
- Copy of residence permit (where applicable)
- Country of tax residence and the relevant tax number

Additional documents & information, such as bank reference letter (from reputable financial institution), information on the Source and Value of Wealth and planned transaction could also be requested.

Altus Citadel will arrange for you meeting with the bank in order to complete the account opening process.
